2. Purpose of processing; the data of the participants in the SpeleoFotoContest photo contest will be used for the organization of the contest and for the management of the association's archives and any future social initiatives.
3. Disclosure of processed data: the data provided will be used by the SpeleoFotoContest Cultural Association. The processed data will not be used for profiling or given to third parties..
4. Categories of data processed: data processed are first and last name, date and place of birth, residence, membership in caving groups, telephone and e-mail, photos and video social profiles.
5. Methods and principles of processing: processing will be carried out in compliance with the GDPR and Legislative Decree 196/03 ("Code regarding the protection of personal data"), as well as the principles of lawfulness, correctness and transparency, adequacy and relevance, using paper and computer methods, by individuals authorized by the Association and with the adoption of appropriate protective measures, so as to ensure the security and confidentiality of the data. No automated decision-making process will be carried out.
6. Retention period of processed data: 10 years after processing.
7. Transfer of data abroad: no authorized transfer of data to recipients based outside the EU.
8. Rights of the data subject: at any time the undersigned may exercise, pursuant to Articles 15-22 of EU Regulation No. 2016/679, the right to:
 - request confirmation of the existence or non-existence of his/her personal data;
 - obtain information about the purposes of the processing, the categories of personal data, the recipients or categories of recipients to whom the personal data have been or will be disclosed, and, when possible, the retention period;
 - obtain correction and deletion of data;
 - obtain restriction of processing;
 - achieve portability of data, that is, receive them from a data controller in a structured, commonly used, machine-readable format and transmit them to another data controller without hindrance;
 - object to the processing of data at any time and also in the case of processing for direct marketing purposes;
 - object to automated decision-making related to individuals, including profiling;
 - request from the data controller access to, rectification or erasure of personal data or restriction of processing concerning him or her or to object to its processing, as well as the right to data portability;
 - revoke consent at any time without affecting the lawfulness of processing based on consent given
